



**Application for Reduced Graduate Tuition
In Support of Dual Credit Instruction**

WHEREAS, Lakeland University, as a recognized leader in delivering bachelor's and master's degrees through flexible options and learning platforms, acknowledges the value of providing affordable graduate-level courses in support of dual credit instruction for high school and technical college instructors; and

WHEREAS, Lakeland University is committed to supporting educators at partnering high schools and technical colleges in attaining the graduate credits necessary to deliver dual-credit courses in high school settings,

NOW, THEREFORE, Lakeland University offers a number of graduate courses to qualified high school and technical college educators at a reduced tuition rate. Conditions of the partnership are as follows:

- I.** Educators must have the support of their principal/supervisor to teach or prepare to teach dual credit courses.
- II.** Educators must register for an approved course through the Lakeland University website and pay any applicable registration fees.
- III.** Educators must complete courses in recommended sequence.
- IV.** Educators are subject to the same disclosure requirements, billing terms, policies, rules and regulations, as published, as all other students. The University has the right to revoke enrollment due to non-commencement of enrollment, non-payment, and/or violation of policies.
- V.** Educators are only eligible for a reduction in tuition on the first attempt of the course.
- VI.** Neither party may assign this agreement to any other group or individual.

Effective summer 2018, eligible educators may enroll in appropriate graduate-level courses through Lakeland University at a discounted tuition rate of \$210 per semester hour; therefore, the tuition for a three semester hour course per participant will be \$630. The rates may be subject to Lakeland University Board approval on an annual basis. No other discount or institutional aid will apply. Students are responsible for any associated course or lab fees at the published rate(s).

Lakeland offers several courses within its graduate programs that qualify for this program. Both parties acknowledge that availability of each course varies by term, depending upon registrations of other students as well as course schedules in general.
