# **Off-Campus Login Information**

To access the library databases:

- Enter the user name and password.

# **Finding Journal/Magazine Articles**

Access complete articles at no cost! Magazine articles, scholarly journals, and news articles are a click away. The library provides numerous databases to help you find articles on criminal justice topics.

Need a scholarly article? Databases include an option to limit your search to scholarly journals.

Can't get to the library for a copy of the article? Databases include an option to limit your results to full text (those items with a complete article attached).

## **How Can I Find This Article?**

Have you found a citation for an article in your textbook or elsewhere that you would like to locate? Give our *E Journal List A-Z* a try.

Enter the name of the journal in which the cited article appeared. <u>E Journal List A-Z</u> will identify if the article is available online and provide a link to that database. . **E Journal List** also lists magazines/journals available in print in the library.

# **Inter-library Loan**

Found the perfect article, but it is not available online? Don't despair! Give the library's interlibrary loan services a try. Fill out the <u>interlibrary loan request form</u> (Lakeland.edu/Request). We will request the article from another library and email it to you.

# **Primary, Secondary & Tertiary Sources**

A primary source in law is defined as the actual statement of the law from the creator such as court, legislature, executive agency, or President or governor. This would include the Constitution of the United States.

A secondary source interprets or analyzes the primary source. Examples are a law review or journal article.

A tertiary source such as an encyclopedia provides an overview of a topic.

### Finding Court Cases, Laws & Codes

<u>LexisNexis®</u> provides access to full text court decisions and state and federal laws and regulations. Limited access to international law resources is included. Use the Shepardize® feature to track all cases citing a particular case.

# **Learning Express**

<u>Learning Express</u> contains practice tests for criminal justice students. In addition to skill building practice tests for reading, math, and writing, this product features several occupational tests for law enforcement careers such as police officer, probation officer and state trooper.



# Online Library Resources for Criminal Justice

#### **Online Books**

Lakeland's online library contains a wealth of online books covering a wide variety of topics in its eBook Collection.

Access the site and enter your search terms in the search box. Click *Search*. All items in your results list will include two options for viewing the book. The *eBook Full Text* option allows the reader to read the book or sections of the book online.

If you want to download the book to read offline on a mobile device, use the *Download* (offline) option. You will need Adobe Digital Edition (free) and an EBSCO account (free). Detailed directions can be found in the *Find Books* section of *Library Resources* on Blackboard.


# Citing an article from ProQuest?
